STAFF RECOMMENDS THE BOARD OF DIRECTORS:

BACKGROUND

On September 20th, 2023, Governor Newsom signed Senate Bill No. 553 ("SB 553") into law, which requires certain California employers to take steps to prevent and respond to workplace violence. Notably, SB 553 added Section 6401.9 to the California Labor Code, which, effective July 1st, 2024, requires covered employers to adopt a comprehensive workplace violence prevention plan that includes procedures for identifying and evaluating workplace hazards. Additionally, Labor Code 6401.9 mandates preventative measures and regular training programs for employees.

DISCUSSION

In response to these legislative requirements, it is essential that the District adopts a Workplace Violence Prevention Plan that complies with SB 553 and Labor Code 6401.9. The plan will outline strategies for hazard identification, risk assessment, and implementation of safety controls. Key components of the plan will include:

- Responsibility and Authority
- Compliance Information
- Hazard Assessment and Corrective Measures
- Incident Investigation and Response Plans
- Training and Education

Therefore, the staff recommends that the Board of Directors approve the new Workplace Violence Prevention Plan. This will ensure compliance with the new legal requirements and will enhance employee protection within the District.

FISCAL IMPACT

There is no fiscal impact associated with this item.
