WATER SOFTENER USE

AN ORDINANCE OF PAUMA VALLEY COMMUNITY SERVICE DISTRICT AMENDING SECTION 2 OF ORDINANCE NO. 7 BY PROHIBITING REPLACEMENT OF WATER SOFTENERS INSTALLED AND IN OPERATION ON OR BEFORE JULY 31, 1972, WITH OTHER THAN WATER SOFTENERS OF THE CYLINDER TYPE.

WHEREAS, on August 8, 1972, the Board of Directors of Pauma Valley Community Services District adopted Ordinance No. 7, entitled "AN ORDINANCE OF THE PAUMA VALLEY COMMUNITY SERVICES DISTRICT REGULATING AND PROHIBITING THE DISCHARGE OF CERTAIN SOLUTIONS INTO THE SEWER SYSTEM OF THE DISTRICT"; and

WHEREAS, said ordinance, among other things, prohibited the discharge into the sewer system of the Pauma Valley Community Services District, brine of chloride solution resulting from recharging or recycling of water softeners; and

WHEREAS, the provisions of said Ordinance No. 7 excepted from its provisions water softeners that were installed and in operation within the District on or before July: 31, 1972; and

WHEREAS, the Board of Directors of the Pauma Valley Community Services District has deemed it necessary for the public safety, health and welfare of those firms and entities within the District to reduce the brine or chloride solution being discharged into the sewer system of the Pauma Valley Community Services District as a result of the recharging or recycling of any water softener;

NOW THEREFORE, BE IT ORDAINED by the Board of Directors of Pauma Valley Community Services District as follows:

1. Section 3 of Ordinance No. 7 is hereby amended to read: "There shall be excluded from this ordinance any water softeners which were installed and in operation within the Pauma Valley Community Services District on or before July 31, 1972. Provided, however, that any replacement or substitute of such exempted water softener shall

not be excluded from compliance with the provisions of this ordinance."

Section 2. All the provisions of Ordinance No. 7 of the Pauma Valley Community Services District, except as amended by this ordinance shall remain unchanged and in full force and effect.
