INCREASING SEWER CONNECTION FEES

AN ORDINANCE OF PAUMA VALLEY COMMUNITY SERVICES DISTRICT INCREASING THE SEWER CONNECTION FEES

WHEREAS, the Pauma Valley Community Services District ("District") is a public agency organized under the Community Services District Law set forth in Government Code Section 61000 *et seq.*; and

WHEREAS, the District has the authority to acquire, construct and operate facilities for the collection, treatment and disposal of sewage and waste of the District and its inhabitants; and

WHEREAS, the District Board recently adopted Ordinance No. 50, under which the District consolidated and restated all of the District's current fees, rules and regulations adopted pursuant to previous ordinances and subsequent minute order actions of the Board for sewer service connection and service; and

WHEREAS, the Ordinance No. 50 also adopted the fees and charges for sewer service connection and service set forth in the previous ordinances and minute orders of the Board; and

WHEREAS, specifically, Section 1(a) of Article VI of Ordinance No. 50 provides that the Connection Fee for each EDU within the existing Sewer System grid shall be \$4,300.00. The Connection Fee per EDU outside the existing Sewer System grid is \$12,630.00; and

WHEREAS, since the adoption of Ordinance No. 50, the District Board desires to increase the Connection Fees for EDUs within and outside the existing Sewer Service grid; and

WHEREAS, as a result, this Ordinance shall repeal and replace Section 1(a) of Article VI; and

NOW, THEREFORE, the Board of Directors of Pauma Valley Community Services District ordains as follows:

<u>Section 1.</u> The above Recitals are true and correct and are incorporated herein and made an operative part of this Ordinance.

<u>Section 2.</u> Section 1(a) of Article VI of the Ordinance No. 50 is hereby repealed and replaced with as follows:

(a) Amount of Connection Fee. The Connection Fee shall be applied to each EDU connected to the Sewer System. The number of EDUs prescribed in Article VII shall be used to compute the amount of the Connection Fee. The Connection Fee for each EDU within the existing Sewer System grid shall be \$7,733.00. The Connection Fee per EDU outside the existing Sewer System grid shall be \$12,956.00.

Section 3. This Ordinance shall take effect immediately upon adoption.

<u>Section 4.</u> If any section, subdivision, sentence, clause or phrase of this Ordinance is, for any reason, held to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the validity or constitutionality of the remaining portions of this Ordinance; it being hereby expressly declared that this Ordinance and each section, subsection, sentence, clause, and phrase hereof, would have been prepared, proposed, adopted, approved and ratified irrespective of the fact that any one or more other sections, subsections, sentences, clauses or phrases be declared
